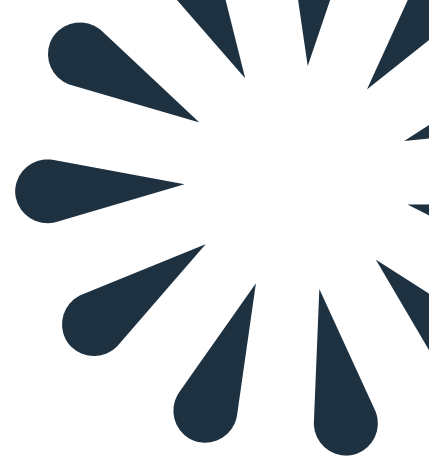

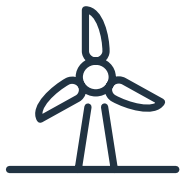


Why renewables?

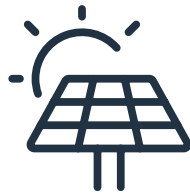
Renewables are a reliable, long-term and sustainable alternative to fossil fuels that will play a key role in the transition to a Net Zero world.
