- Marsham USD Transitional Issuers Fixed Income Fund seeks to obtain its investment objective by investing primarily in Debt Securities issued by companies that have not yet been recognized as ESG leaders but are on a path of sustainability transition.
- The Fund invests primarily in corporate bonds, both investment grade and sub-investment grade, mainly in developed markets, denominated in USD.
- Leverages an in-house fundamental analysis supported by a dedicated team of credit analysts.

CURRENT POSITIONING

Despite solid economic data, FED officials are still worried about inflation and are willing to consider further rate hikes if needed. The credit rating agency Fitch downgraded the US government's credit rating from AAA to AA+ due to concerns about unsustainable debt, deficits and heightened political disfunction. While volatility is likely to persist in the second-half of 2023, there are pockets of well-priced quality credits. Businesses will need to adjust to higher debt costs, which means selection and careful due diligence remains of key importance. We remain positioned in higher quality and shorter duration securities due to flat yield curve.







